Friedenberg Hired as Chief Fund and Business Development Officer

Jon Friedenberg joined the MHD Executive Management Team as its new Chief Fund and Business Development Officer. Friedenberg will direct all activities related to business development, fundraising, marketing, planning, government relations, media relations and external communications for the District. He will also manage strategies to increase philanthropy and oversee the MGH Foundation.

Friedenberg has a strong background in the management of non-profit organizations, hospital foundations and fundraising. Most recently, he was Vice President of El Camino Hospital where he founded the Genomic Medicine Institute, South Asian Heart Center, the Fogarty Institute for Innovation and the Center for Technology Integration. At El Camino, Friedenberg quadrupled fundraising and secured a \$148 million bond measure for the hospital.

LBL Architects Continue Design Process for New MGH

MHD is continuing to work with LBL Architects on the design for the new, seismically-retrofitted MGH. In the coming months, LBL will work with environmental impact consultants, structural engineers, land surveyors, traffic engineers, LEED consultants and landscape artists among others to continue work towards a final building plan.

New Partnerships for MGH

Union Bank and Moss Adams LLP to Partner with MGH

Union Bank will provide primary banking services for MGH. This will include provisions for cash management systems, general depository relationships, payroll and accounting. Union Bank was selected based on their strong support for hospitals, excellent reputation and willingness to provide credit facilities.

Moss Adams LLP is the largest regional accounting firm on the West Coast and has extensive experience within the healthcare field. It is expected MGH will utilize selected consulting services in addition to audit services.
