Board Approves Corrective Process, Roles & Powers

Setting Up the Framework for Governance

At last week's regular board meeting, MHD approved the Corrective Action Process and the Hospital and District Board Roles and Reserve Powers. While MGH will not be under community governance until June 30, 2010, MHD set in place a framework to guide the District and the Hospital.

The Corrective Action Process was developed in anticipation of possible, though highly unlikely, issues. Under MHD oversight, MGH will be held to specific performance goals and metrics (results will also be made public). The Process will provide early signs of potential problem areas well in advance of serious issues.

As a result of the transfer, the relationship between MGH and MHD will have a fundamentally different dynamic. Whereas with Sutter, MHD and MGH have a landlord-tenant relationship, after the transfer, MHD and MGH will have a parent-subsidiary relationship. The Hospital and District Roles and Reserve Powers delineate the responsibilities and authorities assigned to the District Board and the Hospital Board under this new relationship.
