All metrics are in compliance, with the exception of "Physician Engagement" (Schedule 3) being in partial compliance: The data shown is the 2017 data rather than the 2018 because, as a cost-cutting measure, the survey was not done in 2018. He noted that the survey should have been performed, it being required in the MGH Bylaws, and that is will be resumed in the future. He noted that the Paragon Electronic Medical Record system has been a major factor in physicians' low satisfaction scores.
