MINUTES

1. Call to Order and Roll Call

Chair Alfrey called the Regular Meeting to order at 5:31 pm.

Board members present: Chair Edward Alfrey, MD; Vice Chair Brian Su, MD; Secretary Jennifer Rienks, PhD (via Zoom); Ann Sparkman, RN/BSN, JD; Samantha Ramirez, BSW

Staff present: Eric Brettner, CFO; Colin Leary, General Counsel; Tricia Lee, EA

Staff Absent: David G. Klein, MD, CEO

2. General Public Comment

There was no public comment.

3. Approve Agenda

Ms. Rienks moved to approve the agenda as presented. Ms. Sparkman seconded. Vote: all ayes.

4. Approve Minutes of the Regular Meeting of September 10, 2024

Ms. Sparkman moved to approve the minutes as presented with minor corrections. Ms. Rienks seconded. **Vote: all ayes.**

5. Bloom Energy Borrowing

Mr. Brettner presented the Bloom Energy borrowing (TAB 2). The Bloom Energy project was previously brought to the board for discussion, at that time the shared saving program to finance was being explored. However, that option proved to be less than optimal. Bloom required a 25% down payment. After tax credits, \$6 million remained for financing, but with an interest rate over 12%. High penalties were set if the hospital opted out, including a termination fee covering all owed funds and an additional \$4 million. The terms were deemed too risky and financially burdensome for the hospital.

Alternative financing solutions included Bank of America (BofA). BofA proposed to finance 100% of the project at an interest rate under 6%.



BofA terms include a 10-year loan with the option to pay down after tax credits are received, reducing the \$15 million loan to \$10 million The loan's structure minimizes initial debt impact, and the full savings of around \$2 million annually will accrue to the hospital post-loan repayment.

6. MHD Board of Directors Resolution No. 2024-05. Approving MarinHealth Medical Center Loan from Bank of America in Connection with Bloom Energy Financing Resolution No. 2024-05 Approving MarinHealth Medical Center Loan from Bank of America in Connection with Bloom Energy Financing (TAB 3) was presented.

Chair Alfrey asked for a motion to approve, Dr. Su moved to approve the Resolution. Ms. Rienks seconded. **Vote: all ayes**

7. Healthcare Advocacy and Emerging Challenges and Trends

Dr. Alfrey provided an update on SB 1432, Seismic Reform. The bill, which would have granted hospitals additional time to comply with the 2030 Seismic Standards, was vetoed by the governor. This setback affects hospitals seeking extensions for seismic compliance, particularly those not classified as crisis, home programs, small, critical access, or district hospitals.

Dr. Alfrey provided an update to AB 896, Seismic Safety and Compliance Bill. The bill has been signed by the governor. This bill provides specific hospitals, such as crisis, critical access, and district hospitals, the ability to seek approval for a delay in the 2030 Seismic Standards compliance.

Dr. Alfrey provided an update on SB 977, which focuses on increasing penalties for assault and battery against healthcare workers. The bill has been signed by the governor.

Dr. Alfrey provided an update on Assembly Bill 1778, which pertains to electric bike safety, primarily impacting Marin County. The bill has been signed by the governor, establishing a pilot program for e-bike riders. The program restricts e-bike use for individuals under 16 and mandates helmet use.

Dr. Alfrey provided an update on SB 1432 Rural Healthcare Preservation. This bill, aimed to ensure the sustainability of small, rural, and critical access hospitals was vetoed by the governor.

Dr. Alfrey provided an update to Proposition 35, which aims to protect medical access by addressing tax regulations and health insurance. This proposition is on the ballot for the November 5, 2024 election.
